- 1) Will enforcement of dog rules impeded sales and/or rentals?
- 2) Not a project to protect small dogs from large dogs.
- 3) By-Laws allow SMALL dogs.
 - a) Define small dog
 - b) On what basis do owners bring large dogs to 9400?
 - c) Why do by-laws specify SMALL dogs?
 - 1) Dogs make people uncomfortable. Large dogs make people very uncomfortable.
 - d) Anyone entering the building is entitled to expect a safe environment.
 - e) Trained dog is important but training isn't a guarantee. By-laws permit small dogs.

Not large dogs if trained.
- 4) House rules prohibit "visiting" dogs.
 - a) Renters prohibited from bringing a dog.
 - b) Owners' guests prohibited from bringing a dog.
 - c) Owners' family prohibited from bringing a dog.
 - d) Allow visiting small dogs when owner is present???
 - e) Provide list of local kennels - allow 30 minutes to remove dog.
 - f) Fine owners who allow visiting dogs? (not for rentals thru rental companies)
- g) Start enforcement immediately.
 - 1) Are you an owner? i.e. name on the deed
 - 2) Is the dog the property of an owner?
 - 3) Is the owner present?

If all 3 are negative, remove dog
 - 4) If owner's dog, get and display dog tag.
- 5) how do we control dog tags?
 - a) How do we verify that dog belongs to an owner?

- b) How many tags may be issued to the owner of a single dog?
 - c) Are tags transferable?
 - d) How do we associate specific dog tags with specific dogs? Numbered tags?
- 6) Should we strategically place bag stations around the 9400 grounds to aid pet owners who inadvertently leave their units without bringing a clean up bag?
- 7) Does lack of enforcement of the by-laws put us at risk of a lawsuit in the event of a serious dog bite incident?
- a) Is the safety of my investment subject to the behavior of your dog?
- 8) How do we deal with the problem of legal small dogs that are reported as being problems?
- 9) Can we develop a list of suggested behaviors for dogs/dog owners?
- 10) How many owners in the building have dogs that are not small dogs?
